ITEM ND. 1: CALL TO ORDER	Chairman Mincer called the meeting to order at 7:30 pm opening with the Pledge of Allegiance.		
ITEM ND. 2: APPROVAL OF MINUTES	MOTION was made by Kerry Welsh, seconded by Dennis Brink, and unanimously carried to approve the April 16, 2013 Minutes as presented.		
ITEM ND. 3: PUBLIC HEARINGS A) Pike County Generator (Leech)	This duly advertised Conditional Use Public Hearing was continued from the Aprill6, 2013 meeting. The applicant, Stephen Leech, was present. There were no other interested parties. Documents entered into evidence included: maps prepared by Fuller: Township Engineer comments; application and narratives; and a recommendation from the Planning Commission for approval with conditions. Mr. leech testified that there will be no hazardous materials kept at the site. Inventory will be minimal and consist mostly of parts for repairs – generator units are generally delivered directly to the installation site. There will be nearly no customer activity as he meets with customers at their homes and there are no units on display. He has submitted a Land Development application to the Planning Commission. MOTION was made by Kerry Welsh, seconded by Dennis Brink, and unanimously carried to approve the Conditional Use Zoning application for Pike County Generator subject to the following conditions: 1. vehicle trips per day cannot exceed the 25 maximum allowed under their PaDDT Minimum Use HDP; 2. Parking spots #4 & #5 are non-typical and shall be labeled and used as "Employee Parking Only"; and 3. final zoning approval is subject to Final Land Development approval. A Court Stenographer was present for the Hearing.		
ITEM ND. 4: OLD BUSINESS A) 2013 Road Materials Bid Award	The Board reviewed the road materials bid results (attached and made part of these Minutes) from the May 6, 2013 Bid Opening and Roadmaster Jim Snyder's awards recommendation. MOTION was made by Dennis Brink, seconded by Kerry Welsh, and unanimously carried to award the 2013 Road Materials bids as follows based on proximity to Township Garage and cost effectiveness of delivery or FOB: Eureka Stone Quarry (all FOB pricing) – 200 tons 9.5mm Wearing Course, 100 tons 19mm binder, 300 tons 2-A stone, 100 tons Aashto #3, 100 tons Surge, and 100 tons 2-B stone; Dingmans Ferry Stone (all delivered pricing) – 900 tons 2-A stone, 100 tons Aashto #3, 100 tons Surge, 400 tons Antiskid, and 300 tons Screenings.		
ITEM ND. 4(B): Updated Solid Waste Management Ord.	The Board reviewed the final draft of the revised Solid Waste Management Ordinance that has been reviewed and approved by PaDEP. The revised ordinance incorporates mandatory curbside recycling that the Township is now required to provide for. MOTION was made by Kerry Welsh, seconded by Dennis Brink, and unanimously carried to advertise the revised ordinance for adoption.		
ITEM ND. 4(C): Other Old Business	There was no Other Old Business at this time.		
ITEM ND. 5: NEW BUSINESS A) Sheriff Phil Bueki	Sheriff Bueki was present to offer "drive'by" services by his Department of the Township Park. He stated that when Deputies are in the area they will drive through the Park to help keep an eye on things. They provide this service to all municipal parks in the county. The Board was very thankful for the service.		
ITEM ND. 5(B): Proposed 2013 Paving Project	The Board reviewed the proposed paving and milling specs for Christian Hill Road prepared by Jim Snyder and our PaDOT Municipal Rep. The estimated cost is \$263,000. MOTION was made by Dennis Brink, seconded by Kerry Welsh, and unanimously carried to advertise for bids for the paving of Christian Hill Road.

Following discussion, MOTH was made by Kerry Welsh, seconded by Dennis Brink, and unanimously carried to purchase the Ne Holland Boomer 20 from Krempasky Equipment in Honesdale in the amount of \$15,893.00 and to utilize the 0% financing for up to 72 months.
