ITEM NO. 1: CALL TO ORDER Chairman Mincer called the meeting to order at 7:00 pm opening with the Pledge of Allegiance.

ITEM NO. 2: APPROVAL OF MINUTES Karen Kleist informed the Board that the Minutes were not complete and requested approval be

tabled.

ITEM NO. 3: **OLD BUSINESS** The Board was in receipt of a Memo from the Planning Commission informing that, in principal, they A) Cees Wit - Zoning Change Request are in favor of the further development of this area as a commercial district subject to points

Jim Snyder submitted quotes he received for 600 LF of 18" plastic culvert pipes, and requested authorization to purchase from John Bonham Road Supplies (lowest) in the amount of \$5,550.00. delivery is included in the price quoted.

Property Tax Abatement (Veteran's)

The Board was in receipt of notification from the Pike County Tax Administration Office that Anne Connor has requested an abatement of 2018 taxes based on qualifying for the Disabled Veterans Property Tax Exemption effective January 2, 2018. MOTION was made by Dennis Brink, seconded by Thomas Mincer, and unanimously carried to approve the abatement of taxes for Anne Connor based on Disabled Veterans Exemption eligibility.

ITEM NO. 9:

TREASURER'S REPORT

MOTION was made by Dennis Brink, seconded by Thomas Mincer, and unanimously carried to approve the April 17, 2018 Treasurer's Report, Bill Payment List, and General Fund balance, and to sian the checks following the meeting.

ITEM NO. 10: PUBLIC COMMENT There were no comments from the public or press.

ITEM NO. 11: EXECUTIVE SESSION The Board recessed to Executive Session at this time to discuss a personnel matter and pending

litigation.

Upon reconvening the regular meeting, Dennis Brink informed the Board that the golf cart at the Park was not working and repairs would cost nearly as much as purchasing a replacement (used). Stateline Golf Carts has a used gas model for approximately \$3800.00. MOTION was made by Thomas Mincer, seconded by Dennis Brink, and unanimously carried to replace the golf cart at the

Park with a newer gas model, not to exceed \$4,000.
