ITEM NO. 1: CALL TO ORDER

Chairman Mincer called the meeting to order at 7:00 pm opening with the Pledge of Allegiance.

ITEM NO. 2: APPROVAL OF MINUTES

MOTION was made by Dennis Brink, seconded by Ed Nikles, and unanimously carried to approve the December 15, 2020 Minutes as presented.

ITEM NO. 3:

**COVID-19 RELATED BUSINESS** 

The Board approved the updated Continuity of Operations Plan. ITEM NO. 4 OLD BUSINESS A) 2020 Tax Levy - Res. No. 2020-06 MOTION was made by Ed Nikles, seconded by Dennis Brink, and unanimously carried to adopt Resolution No. 2020-06, establishing the tax levy for 2021 at 6.5 mils General Purposes, 1.25 mils Fire Tax. and .5 mil EMS Tax.

20201 Budget - Res. No. 2020-07

Karen Kleist informed the Board there was one minor (\$300) correction made on the Final Budget. MOTION was made by Dennis Brink, seconded by Ed Nikles, and unanimously carried to adopt Resolution No. 2020-07, 2021 Budget.

ITEM NO. 4(C):

Garage Project Bid Award

After further investigating the matter of the lowest responsible bidder, it was found that a portion of the information that the Board relied upon was found to be inaccurate or was refuted by persons with more direct knowledge. Although the remainder of the information appears to have been accurate, it is not sufficient to support not awarding the contract to the low bidder. MOTION was made by Ed Nikles, seconded by Dennis Brink, and unanimously carried to rescind the previous motion awarding the contract to Grimm Construction, and further MOTION to award the contract to Mar-Paul Construction as the low bidder.

184 Rehabilitation – Tunnel Road Plans

The Board reviewed the plans for the new higher and wider tunnel to replace the current one on Tunnel Road.

reviewing and working on changes to the requirements.
