Notice is hereby given that the Dingman Township Board of Supervisors will accept sealed proposals until **3:00** p.m. on May **9, 2012**, opened at 3:05 pm, and awarded during their regular meeting on May 15, 2012 at 7:30 pm for the following:

1. VanAuken Hill Road: approx. 783 sy of area to be milled, approx. 969 tons leveling course in place, resurface entire road (approx. 1,110 tons Superpave materials), and linepainting. Work to be completed by August 17, 2012.

Projects must be reviewed with Roadmaster prior to submitting Bids. All work to be performed in accordance with PennDOT Construction Standards (Pub. 408/2000) and Work Zone Traffic Control (Pub. 203 & 203A). **Prevailing Wage Rates apply.** The Township reserves the right to reject any or all bids, either in full or in part.

The successful bidder shall: (a) provide proof of workers compensation insurance and liability insurance in an amount acceptable to the Board of Supervisors; (b) be required to furnish a bond guaranteeing performance of the contract and warranty with sufficient surety in the amount of fifty percent (50%) of the contract within twenty (20) days after the contract has been awarded; and (c) be required to furnish a bond guaranteeing the prompt payment for all materials furnished and labor supplied or performed in the prosecution of the work hereunder with sufficient surety in the amount of fifty percent (50%) of the contract amount within twenty (20) days after the contract has been awarded, & shall provide that every person, copartnership, association or corporation who, whether as subcontractor or otherwise, has furnished material or supplied or performed labor in the prosecution of the work & who has not been paid therefore, may sue in assumpsit on said additional bond in the name of the Township for his, their, or its use and prosecute same to final judgement for such sum or sums as may be justly due him, her, them or it and have execution thereon, provided, however, that the Township shall not be liable for any costs of suit. Upon failure to provide said bonds, the award shall be void.
